If an erroneous debit entry is charged against their account, the Tenant has the right to have the amount of the entry credited to their account by his or her financial institution, if, within fifteen (15) calendar days following the date on which Tenant was sent a statement of account or written notice of such entry or 45 days after posting, whichever occurs first, tenant gives his or her financial institution and CMHA written notice identifying the entry, stating that it is an error and requesting credit back to their account;
