The accelerated Request for Tenancy Approval process is in operation from 8:30am 4:00pm. **Approved** RTAs, submitted between 8:30am and 1pm will be scheduled for inspection, whenever possible, within one business day of submission. And submissions made between 1 & 4pm will be scheduled for inspections within 48 hours, whenever possible. RTAs must be delivered to 1635 Western Avenue and the units must be ready for inspection.
