CMHA recently discovered technical issues with our inspection reports. The issue is caused by a glitch" that is producing inspection reports that show every item listed on the report as a "failed" item. You can easily identify the mishap because the items that are marked incorrectly do not indicate a "responsible party" for the deficiency.

Additionally, we've seen the inspection result of "final fail" noted in the system when the first reinspection "fails" which prompts an abatement to be placed on the unit.

I apologize for the mishap and can assure you that CMHA is working hard with our software vendor to resolve the issues. We will not abate any payments caused by this system error. Owners will be provided a corrected copy of the inspection report and provided an opportunity to correct the deficiencies prior to any abatement of payments.

HUD is considering changing from HQS inspections to a new inspection protocol called UPCS-V. UPCS-V introduces new measures to enhance the consistency and objectivity of the inspection process, and will provide more information about the condition of individual housing units. Congress expressed the need to update the housing quality standards in order to reflect current advances in home inspections and changes to standards of health and safety threats in homes today. Through this initiative, HUD aims to clarify and streamline inspection processes for PHAs and inspectors, while increasing owners' and tenants' access to detailed information about their homes.
