November 22-23, 2018 Proposed changes have been made to the HCV Administrative Plan. A summary of changes is posted online and public comments are being accepted through Mid-December. The changes of interest to you include updates on how Emergency Inspections are handled and Final Fails for Non-Emergency items. Please visit www.cintimha.com and click on the public comments slide.

Also, I'd like to remind owners that the responsibility of who pays the utilities in a unit is established upfront during the rent reasonable and RTA process. If you learn that utilities cannot be established in the tenant's name then a new RTA must be completed and approved by CMHA. After the initial term of the lease the owner may decide to switch who pays utilities. A new rent reasonable assessment must be completed along with a new lease and contract. Additionally, a family residing in a multifamily unit cannot be responsible for utilities in the common areas of a dwelling.

Thank you to everyone who attended the 4h annual Property Owners Appreciation Banquet. The CMHA team worked hard to make the event memorable for all who attended. Your partnership with the HCV program is appreciated. During the banquet, we recognized 13 owners, managers and community partners with the CMHA Celebrates Excellence Award. Inspector's Note: Cold Weather Reminders



The temperature is beginning to drop and Inspections has a few reminders for you. When the outside temperature is 60 degrees Fahrenheit or below it is your responsibility to maintain the heat at 70 degrees. Also, heavy rain, snow and extreme cold can cause renovation delays and we get it. So the weather extensions for exterior work are being permitted on concrete, painting, roofing and other exterior repairs. Please contact Manager of Landlord Compliance Tim Salvador at 513.977.5863 to request a weather extension. All other extension requests should be made in writing to Mr. Salvador prior to the due date for repairs with the Request for Extension form on the HCV Documents Download page. Inspectors will check the repairs in May of 2019.
