QUESTIONS:

1. I visited the site yesterday and noticed that the brick façade needed tuck-pointing in addition to the stone patches. I have went through the bid documents and have not saw anything on tuck-pointing the brick. Can you confirm that the only tuck-pointing is around the stone patches?

ANSWER: Please refer to Section 04 01 42, 1.05 B and 3.02 B.

2. In the general note A page A301, is the tuck pointing for the sandstone only? In the pre-bid meeting I was under the impression that the sandstone repairs were the scope of the work for the masonry repairs.

ANSWER: Please refer to Section 04 01 42, 1.05 B and 3.02 B.

3. Stone patch is called out in multiple areas on the drawings. In the specs it states that "approximate square footages have been listed for each area" but the drawings are only pointing to those areas, not listing the square footages. Also it states that there will be stone unit cost in the bid form and I do not see those. Will either of those be added?

ANSWER: Square foot areas have not been included. Please refer to the highlighted areas to repair. The Bid Form will not include stone unit costs.
