MESSAGE FROM THE CEO:
CMHA IS CULTIVATING
PARTNERSHIPS TO MEET THE
NEEDS OF HAMILTON
COUNTY RESIDENTS

The month of May marks Mental Health Awareness month, a national observance to bring awareness and attention to the importance of well-being. While the observance of mental health began in 1949, it has only recently been an intense focus on this issue and the challenges people living with mental health conditions and their families face daily. Did you know that 1 in 5 U.S. adults experience mental illness each year? One in 20 U.S. adults experience serious mental illness each year. However, only 47% U.S. adults experiencing mental illness receive treatment, and only 65% of U.S. adults experiencing serious mental illness receive treatment. Additionally, one in six U.S. youth have a mental condition with only half of them receiving treatment.

For someone living with mental health conditions, finding and retaining stable housing may be difficult. When safe and affordable housing is inconsistent or nonexistent, this becomes a barrier to recovery for the illness. Many people experiencing mental health conditions tend to cycle in and out of homelessness, jail, shelters, and hospitals.

CMHA continues to cultivate partnerships with community and national organizations in developing and rehabilitating buildings so to assist individuals and families gain access to safe and stable housing. The goals of these efforts are to better assist those who suffer with mental health conditions so they might find better success with recovery.

CMHA began its journey reimagining housing by creating a plan toward a billion-dollar investment to provide better quality housing for individuals and families in 2015. CMHA closed on the first property in 2019 with a total development cost of \$33.4 million. Since that time, we have steadily each year been adding to that development cost as we work towards the billion-dollar goal. We have already impacted the lives of more than 5,000 families throughout Hamilton County.





Understanding the county residents' housing needs is a vital mission for CMHA, one not taken lightly.

#### The current projects in the works set to be completed this year are:

- Riverview Apartments in Walnut Hills rehabilitation and upgrade of facilities
- San Marco Apartments in Walnut Hills rehabilitation and upgrade of facilities
- Logan Commons in Over-the-Rhine new construction of senior housing

### Projects set to complete their financial closing in 2025 and construction completed 18 months after closing are:

- Marquette Manor in North Fairmont rehabilitation and upgrade of facilities
- The Beechwood in Avondale rehabilitation and upgrade of facilities
- Winton Terrace in Winton Hills rehabilitation and upgrade of facilities
- Anderson Township rehabilitation and upgrade of facilities

In cooperation with CMHA's efforts to create "sustainable funding models for quality affordable housing," we often work with community, regional, state, and federal partners to acquire additional funding for our new construction and rehabilitation projects. Congressman Greg Landsman is one of these partners that works tirelessly to assist CMHA in obtaining additional funds for projects. On May 13, he visited and toured The Beechwood in Avondale to gain a better perspective of the current conditions under which residents live. Most of the apartments in the 12-story building have decades old kitchen and bathroom facilities in addition to older dilapidated vinyl tile flooring. Congressman Landsman assisted CMHA in winning a \$1 million Economic Development grant through the federal government, which will provide additional funds for better quality and longer lasting materials.

### HVC Honors and Highlights in Appreciation Banquet for Property Owners

Cincinnati Metropolitan Housing Authority (CMHA) held the Annual Housing Choice Voucher Appreciation Banquet on Thursday, May 1, at Cintas Center. The gala event highlights and honors partners who work with CMHA and the HCV program assisting participants with finding quality affordable homes. Ms. Joy Gazaway acted as the MC and host for the event. She introduced CMHA Commissioner Mrs. Bernadette Watson to kick off the evening with a special message about sharing her experience helping people achieve their dreams. She thanked the property owners for their collaboration with the agency. Mr. Gregory Johnson, CMHA CEO, spoke about the unity and stated, "our greatest strength lies in our partnerships, as you [landlords] work with us daily to provide affordable, well-kept, and well-managed properties for our voucher holders." He thanked them for their partnership with "your assistance and collaboration provide more than 10,000 families across Hamilton County with homes with a quality place to lay their heads and hearts every night." In addition, he expressed gratitude to the CMHA Board of Commissioners and CMHA staff for the work they do every day.

During dinner, Hamilton County Commission President Alicia Reece spoke about her passion for CMHA and Hamilton County's partnership to stabilize families and create more opportunities through affordable housing. She shared her life experiences with her grandmother living in Over-the-Rhine through her childhood and her desire "where everyone can afford to live, and everyone can afford a piece of the American dream." She continued in sharing how the county has provided more than \$40 million for affordable housing from their ARPA funds. In addition, \$17 million from the CDBG funds were directed toward CMHA's Logan Commons project for senior housing. Commission President Reece wrapped up with, "We believe that partnerships are important. We believe that you have to put the money where our mouth is. I believe that people can come through CMHA housing system like my grandmother, like my mother now leading to me being over as president of the Hamilton County Commission...I want to make sure every person in Hamilton County has an equal shot at the American Dream."

Following Commission President Reece, Ohio State Representative Dani Isaacsohn began by thanking property owners for their collaboration, "I want to begin with the most important message to convey, thank you. Thank you for helping thousands of people in this community

have a place to call home for themselves and their families." He continued by sharing about his connection to CMHA and his passion for affordable housing for everyone. "Today, more than ever, the voucher program and the housing you provide is critical," he said speaking to property owners. "The vouchers program is at its core a partnership, and it only works because there are people willing to step up to provide the housing necessary and who recognize that providing housing can be about more than just maximizing financial returns." He concluded with what success can look like for voucher participants and the continued push to "act and legislate" to assist property owners in more ways.

The evening continued with two impactful videos highlighting CMHA's partnership with two agencies and focused on one important program at CMHA. The Family Self-Sufficiency program at CMHA sets participants up for success through goal setting and saving money. The video took a closer look and focused on Angela Walker, a participant who met her goals of graduating from college, getting a quality job, and purchasing a home of her own. It recognizes that CMHA provides additional opportunities to families that assist them in more ways to continue building and growing in their lives. Strategies to End Homelessness is a significant partnership as CMHA provides 1,100 referrals to them to reduce the number of families experiencing homelessness. Through this partnership, CMHA assists families who may not have a fixed, regular, or adequate nighttime residence and helps them improve their quality of life.

CMHA honored two partners with The Partnerships Awards. The first was First Step Home, which works through the agency's project-based voucher program, where a subsidy is attached to a unit and provides housing subsidies for special populations. First Step Home empowers women to overcome substance abuse and achieve self-sufficiency while providing a safe and nurturing environment for their children. The second award went to Greater Cincinnati Realtist, which provides training and educational opportunities for their membership of property owners to better understand and work with CMHA. They also support CMHA's annual Homeownership Fair providing attendees with information on inspections, credit, and other tools to be successful homeowners.

The additional companies and organizations honored were:

Housing Our Heroes Award went to Mr. Jamie Collier of 4th Street Management for his advocacy in seeking safe and affordable places for those who have served in the armed forces. He assists veterans in moving quickly through the housing process. He often checks on them following their moves into homes to ensure they have what they need.

The Modernization and Neighborhood Stability Award was presented to Fairfield Homes for their construction of Blair Lofts, a 64-unit apartment building in Avondale with one to three bedrooms.

The Commitment to Housing was bestowed on Found House which provides shelter, housing, and support for families experiencing housing insecurity. The Found House staff works tirelessly with tenants to help them understand the processes and keep secure housing.

HCV presented the Initiative Award Plum Tree and Maxine Milner for their enthusiasm in taking advantage of training opportunities in addition to their reliability and professionalism in their repair.

The two Beautification Awards went to Action Property and Second Avenue for their hard work in providing curb appeal and well-kept landscaping.

Aven Realty and 1728 Lincoln earned the Newcomer Awards for modern and updated touches to their newly acquired properties in their first year with CMHA.

Following the award presentations, Lisa Isham, CMHA Vice President of HCV Program Services thanked the partners for their collaboration in providing quality affordable housing opportunities for HCV participants. She also thanked CMHA staff for their dedication.

CMHA Vice Chair of the Board of Commissioners, Ms. LaVerne Mitchell closed out the banquet with special acknowledgement and gratitude, on behalf of the Board of Commissioners, to the property owners, CMHA staff, and Mr. Johnson, for his passion and leadership of the organization.

his wealth of knowledge.






### How to Do Business with CMHA
