### 2.1 Products

  - a) Make Ready Procedures will apply and have been incorporated into the Project Manual.
  - b) Coordinate with Project Manager for keys to project.
- 2.3 Exterior



- a) In addition to item (2) of the scope of Work, Exterior Landscaping please include all necessary lawn mowing and trimming. Bag and remove all cut grass and blow clean all walks and drive areas.
- **b)** Item (7) Windows Glass block windows to remain.
- c) Item (10) Entryways Rear entry door will include deadbolt hardware to match new.
- **d)** Item (3) All concrete stair approaches shall be demoed and reinstalled to meet code and lessen the steep incline.

### 2.4 Interior

- a) Item (12) HVAC Install New central air unit outside and connect to heating system to provide central air.
- **b)** Item (35) Garage Ensure all concrete walls are repaired using an approved epoxy injection method and treated the same as the basement scope of Item (33).
