The following additions, deductions, changes and corrections to the proposal and specifications for the above referenced project shall hereby be incorporated into the work, and their affect on the proposal shall be reflected in the Offeror's proposal. Offerors shall also verify this fact by indicating the receipt of the addendum in their proposal.

QUESTIONS:

1. Regarding the maximum allowable per hour charge for additional services as set out in Attachment B.5., the recommended Federal wage and benefits per hour well exceeds the maximum CMHA has placed on the fee schedule for those services. For example, on the HUD wage rate recommendations, that are included in the RFP, states a painter's basic wage is \$32.62 plus fringe benefits of \$15.96, that's a total wage of \$48.58 which is way above the \$27 maximum set on the fee schedule for fence painting. How can we meet the HUD rate standards with a maximum price set on the RFP that is way below HUD recommendation? **The Additional Services Fee Form has been revised to reflect the mandated minimum rates allowed under the HUD Wage Rate Recommendation form which is included in the terms and conditions of the RFP. Vendors submitting rates less than the minimum rate allowed on this form will be rejected.**
